MobileIQ, Inc. ("MobileIQ") has a firm commitment to safeguarding the privacy of our clients, and our clients' customer data. This page will inform you about MobileIQ's information gathering and dissemination practices for Headlight™.

MobileIQ is committed to providing you a safe environment to upload and use your business and customer data. Neither your business information nor your customer data is visible to any other MobileIQ clients or to outside parties.

INFORMATION YOU EXPLICITLY PROVIDE

1. In order to establish your Headlight™ Account ("Account"), you will be asked to provide certain business and/or personally identifiable information to us, such as your name, business name, mailing and email address, phone number, and a credit card number and expiration date. We will use that information to bill you and to communicate with you concerning Account issues or other issues.
2. MobileIQ only uses your business and personal information to conduct business with you. Your business or personally identifiable information will not be rented, sold or shared with any third party, except as described in this Privacy Statement. MobileIQ may disclose information it has collected from any Headlight™ User and/or content any User has made available via User's Account when it believes that the law or legal process requires it, or when it is necessary to do so to protect the rights or property of MobileIQ.
3. We will never sell or share your customer data with any third parties, contact your customers directly without your permission, or use your data for our own business advantage. We will not utilize your data in our databases to compete with you, or to market to, advertise to, or contact your clients for any other means of profit. We respect the privacy of our subscribers, and the privacy of their client data.
4. We use aggregate non-personal information (i.e. information that does not include personally identifiable data) to improve the content and quality of the Headlight™ Fleet Intelligence Service, for product development, marketing and promotional purposes. We will never make that aggregate non-personal information available to any third parties except as described in this Privacy Statement.
5. We may be required to transfer personal, business or aggregate non-personal information about you if MobileIQ is acquired by or merges with another company. In this event, MobileIQ will notify you before any such information is transferred and becomes subject to a different privacy policy.

CREDIT CARD INFORMATION

1. To establish a monthly billing Account, MobileIQ will ask for your credit card information.
